## **Preliminary Statement**

By Declaration of Condominium of The Greens II of St. Augustine Condominiums dated February 17, 2004 and recorded in Official Records Book 2139, page 1018, of the Public Records of St. Johns County, Florida (hereinafter collectively referred to as the "Declaration"), Declarant has submitted certain lands to the condominium form of ownership as Phase 1 of The Greens II of St. Augustine Condominiums. Under paragraph 20 of the Declaration, the Declarant reserved the right to develop in one or more additional phases and to submit to the condominium form of ownership under the terms and conditions of the Declaration all or a part of the real property more particularly described on Exhibit "B" to the Declaration and identified therein as the "Future Phase" and "Phase 2". Declarant desires to amend the Declaration to add the Future Phase described on Exhibit "A" to this Amendment to become a part of Southern Grove Condominiums (the "Condominium").

- 1. <u>Submission of Real Property to Condominium Ownership</u>. Declarant is the owner of the real property described on Exhibit "A" attached hereto. Declarant hereby submits the real property described on Exhibit "A" hereto to the condominium form of ownership as Phase 2 of the Condominium in accordance with the Declaration and the provisions of Chapter 718, Florida Statutes.
- 2. <u>Surveyor's Certificate of Substantial Completion</u>. In accordance with *Section 718.104*, *F.S.*, Declarant hereby amends the Declaration to include the Surveyor's Certificate attached hereto as Exhibit "C" for the purpose of evidencing substantial completion of the units described in the Surveyor's Certificate.
- 3. <u>Fractional Share</u>. The fractional share in the Common Elements, Common Expenses and Common Surplus appurtenant to each Unit in the Condominium following the addition of the

Future Phase described on Exhibit "A" is set forth on Exhibit "D" to this Amendment. Declarant hereby amends the Declaration to delete the Exhibit "D" attached to the Declaration and substitute in its place the Exhibit "D" attached hereto.

4. <u>Limitation</u>. Except as provided herein, the Declaration is not otherwise amended and remains in full force and effect.
