WHEREAS, the property encumbered by this NBRC Property Owners Association's Collection Policy (the "Collection Policy") is the property restricted by the Declaration of Covenants, Conditions and Restrictions for River Chase, various units, recorded as document number 9906010006, 9906027879. 9906031628, 200106021818, 200106021817, 200206017405, 200206017406. 200206039260,200406019014, 200206039259. 200406019015, 200506016924, 200506020156, 200606019897, 200706001411, Official Public Records of Real Property of Comal County, Texas, (hereinafter called the "Declaration"), as same may be amended from time to time, and any other property which has been or may be annexed thereto and made subject to the authority of the NBRC Property Owners Association (the "Association");

WHEREAS, reference is hereby made to the Declaration for all purposes, and any and all capitalized terms used herein shall have the meanings set forth in the Declaration, unless otherwise specified herein;

WHEREAS, pursuant to Chapter 209 of the Texas Property Code, the Board of Directors (the "Board") of the Association hereby adopts this Collection Policy for the purposes of establishing a uniform and systematic procedure to collect assessments and other charges of the Association; and

WHEREAS, the Board has established that it is in the best interest of the Association to amend.

NOW, THEREFORE, BE IT RESOLVED THAT the Association does hereby amends the EIGHTH AMENDMENT TO THE BYLAWS OF NBRC PROPERTY OWNERS ASSOCIATION as follows:

Article 3, Section 3.1 is amended to read as follows:

3:1 Annual Meetings. The first annual meeting of Members shall be within one year from the date of incorporation of the Association or not later than thirty (30) days after fifty-one percent (51%) of the Lots have been sold, whichever last occurs. Subsequent annual meetings of Members shall be held during the first fifteen days in November of each year thereafter at the hour of 7:00 o'clock p.m. on a day chosen by the Board of Directors.
